This document describes certain changes to the Benefit Booklet of the Oregon Homecare Workers Supplemental Trust (“Supplemental Trust”) and the Oregon Homecare Workers Benefit Trust (“Benefit Trust”) (collectively, the “Trusts”). The page numbers refer to the sections of the Benefit Booklet that are changing. Please read this summary carefully, and keep it with your Benefit Booklet.

Enrollment Rules – Trust-approved Plans for 2017

The following language is added to page 11 in the section entitled “Enrolling During Open Enrollment.”

Participants Residing in Other States

- For 2017 California: Anthem Silver \$2,500 Deductible 70 HMO Plan; Anthem Silver \$2,500 Deductible 70 EPO Plan; or Anthem Silver \$2,500 Deductible 70 PPO Plan, depending upon which Plan is available in your area.
- For 2017 Washington Kaiser Service Area: Kaiser Permanente \$2,000 Deductible Silver 2000/30 HMO Plan
- For 2017 Washington Non-Kaiser Service Area: BridgeSpan \$3,500 Deductible Silver Essential Plan
- For 2017 Washington Grant, Island, Klickitat, Pacific, Skamania, Wahkiakum and Whatcom Counties: LifeWise \$3,000 Deductible Silver Essential EPO Plan
- For 2017 Washington Stevens County: Community Health \$2,500 Deductible Silver Essentials Plus Plan
- For 2017 Washington Mason and Lewis Counties: Group Health \$3,000 Deductible Silver Core HSA Plan

Exchange Medical Insurance

The following language is added to the end of the first paragraph of the sub-section entitled “Washington” on page 18.

- The 2017 Trust-approved plans in Washington are the Kaiser Permanente \$2,000 Deductible Silver plan (if you live within the Kaiser Service Area), BridgeSpan \$3,500 Deductible Silver Essential plan (if you live outside the Kaiser Service Area), the LifeWise \$3,000 Deductible Silver Essential EPO plan (if you live in Grant, Island,

The following language is added to the end of the first paragraph of the sub-section entitled "California" on page 19.

- The 2017 Trust-approved plans in California are the Anthem Silver \$2,500 Deductible 70 HMO Plan; Anthem Silver \$2,500 Deductible 70 EPO Plan; or Anthem Silver \$2,500 Deductible 70 PPO Plan, depending upon which Plan is available in your area.
